**Environment:** In accordance with the NEZ regulations for Crosskart 2018. Waste is to be left by the trash

cans in the paddock. Everything brought to the race must be taken home again. Liquid collector and tarpaulin must be under the participant's vehicles while in paddock.

**Running of the event:** The event is implemented in accordance with the NEZ regulations for Crosskart 2018.

Starting order for the qualifiers and finals is as follows: Mini, 85cc, 125cc, Senior +40, 250cc,

650cc, Xtreme,







The qualifying heats run 4 laps while the finals run 6 laps. Mini drives 4 (finals 6) laps on a special racetrack.

**Start:** In Accordance to NEZ regulations for Crosskart 2018, section 18.

The light turns from nothing to green.

**Racetrack:** 833 meters (860 with Joker) Tarmac and gravel.

**Finals** 

Prize giving ceremony 30 minutes after preliminary result publication

on official notice board.

**Results:** Scores/result list is posted after completed qualifying round on the official notice board in

the paddock by the toilet building.

**Prices:** Award ceremony takes place 30 minutes after the results list determination. Prizes,

according to NEZ regulations for 2018.

**Protests:** Protests shall be made in accordance with the Competition Regulations. Protests time

concerning the preliminary heats is 10min and the finals it must be done within 30 min after preliminary result publication on official notice board. Protest fee is 300€. If the protest is confirmed by the decision of the stewards fee will be returned. If drivers is not satisfied he must complain to organizing ASN. The fee is: NOK 10 000,- No reimbursement is paid for the reassembly of components during a technical inspection. If the decision about a technical inspection is based on a protest from a co-competitor, and no fault is found, the reassembly is paid by the person that issued the protest. The cost cannot be more than the price for the work to be performed by a certified auto repair shop. In case of protest the competitor is responsible for any costs for transport of the car if the inspection is to be performed at a later time. If there is a problem found during the analysis of fuel the cost for the analysis is

paid by the competitor.

Time penalties and refusing the start for late arrival in the pre-grid area/staring grid are not

susceptible to appeal.







**Liability:** The race participant does so at his own responsibility and own risk. NBF, organizers or

officials cannot - without cause - be held responsible for injury or damage to property during

the competition afflicting participants.

**Miscellaneous:** Each participant may bring 3 mechanics/helpers – free of charge. Others pay full entrance.

Bicycles and mopeds in the area is forbidden.

Max area of the paddock per participant 78 square meters (e.g. 13mX6m) At arrival, please wait for chief paddock to refer parking space in paddock.
